

WHO ARE ELIGIBILITY: Any establishment or contractor "registered under the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 [BOCW (RECS) Act, 1996] or under the Contract Labour (Regulation and Abolition) Act 1970 [CL(R&A) Act, 1970] or licensed under CL(R&A) Act, 1970" for executing "building and other construction work" as defined under the BOCW (RECS) Act, 1996 and employed 100 or more building workers in the project and have achieved minimum 1,000,000 Safe man hours during the assessment period [OR] Any Project Management Consultant (PMC) ,whose client or any General Consultants or any consultants, whose client or their contractors registered under BOCW (RECS) Act., 1996 or CL (R&A) Act, 1970 or licensed under CL (R&A) Act, 1970 for executing "building and other construction work" as defined under the BOCW (RECS) Act, 1996 and employed 100 or more building workers in the project and have achieved minimum 1,000,000 Safe man hours during the assessment period are eligible for these awards.



WHO ARE ELIGIBILITY: Any manufacturing/ factory registered under the Factories Act, 1948 and commencing manufacturing activities like making, altering, repairing, ornamenting, finishing, packing, oiling, washing, cleaning, breaking up, demolishing [OR] otherwise treating or adapting any article or substance with a view to its use sale, transport, delivery or disposal [OR] pumping oil, water, sewage [OR] any other substance [OR] generating, transforming [OR] transmitting power [OR] composing types for printing, printing by letter press, lithography, photogravure [OR] other similar process [OR] book binding or constructing, reconstructing, repairing, refitting, finishing [OR] breaking up ships [OR] vessels or manufacturing process, as well as Micro enterprise, small enterprise, medium enterprise (MSME) who have which has filed Memorandum with the District Industries Centre as required under the Micro, Small and Medium Enterprises Development Act, 2006 are eligible for this awards for the assessment period.




